

## **DONOR BILL OF RIGHTS AND TERM & CONDITIONS**

Please support our work around the world with a gift to our foundation. You can rest assured that we will be good stewards of your generous donation.

By electing to give a donation in response to a KSCF US campaign, you agree to be bound by the following terms and conditions. If you do not agree to be bound or cannot comply with any of the terms and conditions, do not continue the donation.

### **Terms of your gift:**

Thank you for contributing to a Kailash Satyarthi Children's Foundation of America, Inc. (KSCF US) campaign. Your donation is to KSCF US, a corporation formed pursuant to the District of Columbia Nonprofit Corporation Act, DC Code Title 29, Chapter 4. KSCF US is a 501c (3) public charity, which means you can deduct contributions you make to KSCF-US under IRC Section 170. KSCF US may elect to re-grant your donation to a charity or charities, which further its tax-exempt purpose. Per our agreement with all grant receiving organizations, and in accordance with the Internal Revenue Service's Regulations, KSCF US maintains the exclusive legal control over all donation funds. If an organization fails to comply with KSCF US' Standards for Participation, KSCF US reserves the right to disseminate donation amounts to a complementary organization. KSCF US EXPRESSLY RESERVES THE RIGHT TO DISSEMINATE DONATION FUNDS IN ITS ABSOLUTE AND SOLE DISCRETION, SUBJECT TO THE FOUNDATION'S GOVERNING DOCUMENTS AND IN FURTHERANCE OF ITS CHARITABLE PURPOSE.

Please consult your tax or financial advisor for specific questions about your gift. It is anticipated that all KSCF US approved grant recipient organizations qualify for 501c (3) status and donations should be tax deductible. Your donation is immediate and irrevocable.

KSCF US appreciates your donation and your support of our mission. Our budget and ongoing financial health relies on accounting for and accepting irrevocable, non-refundable donations from the public. Therefore, KSCF US considers all donations to be nonrefundable. KSCF US may consider returning donations to the donor, but only in limited circumstances. If you have made an error with your donation or changed your mind about contributing to our organization, please contact us at [contact@satyarthi.org](mailto:contact@satyarthi.org). Depending on the circumstances, KSCF US will consider your request if it is made within Thirty (30) days of the original donation. KSCF US may ask for proof of identity before issuing a refund, and all refunds are returned using the original method

of payment. For example, if your donation was made by credit card, your refund will be credited to that same credit card account. You are responsible for all tax considerations that may arise if your donation is refunded.

## **DONOR BILL OF RIGHTS**

Philanthropy is based on voluntary action for the common good. It is a tradition of giving and sharing that is primary to the quality of life for so many. To assure that philanthropy merits the respect and trust of the general public, and that donors and prospective donors can have full confidence in the not-for-profit organizations and causes they are asked to support, we declare that all donors have these rights:

- 1) To be informed of the organization's mission, of the way the organization intends to use donated resources, and of its capacity to use donations effectively for their intended purposes.
- 2) To be informed of the identity of those serving on the organization's governing board, and to exercise prudent judgment in its stewardship responsibilities.
- 3) To have access to the organization's most recent financial statements.
- 4) To be assured their gifts will be used for the purposes for which they were given.
- 5) To receive appropriate acknowledgment and recognition.
- 6) To be assured that information about their donations is handled with respect and confidentiality to the extent provided by law.
- 7) To expect that all relationships with individuals representing organizations of interest to the donors will be professional in nature.
- 8) To be informed whether those seeking donations are volunteers, employees of the organization or hired solicitors.
- 9) To have the opportunity for their names to be deleted from mailing lists that an organization may intend to share.
- 10) To feel free to ask questions when making a donation and to receive prompt, truthful and forthright answers.
